transit network your government is building until it is extended – from Downsview to McCowan. Your government has recognized this past failure and in the last two election campaigns your party made bold commitments to getting this critical piece of infrastructure 'DONE'.

The March 26 Budget needs to demonstrate a real commitment with a dedicated line item with funding assigned to the next several

years showing that your government is committed to completing the business case, getting to work on detailed design, acquiring the necessary properties, conducting a TPAP, locating utilities etc.
